I understand and agree that any gun sent in for refinishing will be completely disassembled before the surface preparation process can begin and any gun that requires any amount of disassembly will be charged the full disassembly and reassembly fee (less the dealer discount). I understand and agree that any item sent in for metal finishing that is a partially assembled assembly will be assessed a full disassembly and reassembly fee (less the dealer discount); disassembly and reassembly fees will not be pro-rated.

I understand and agree that any gun or component sent in for metal finishing (NP3, NP3+, ArmorLube, Black Oxide, Stainless Blackening, or Parkerizing) will be sent in one of the following two (2) configurations: 1. Fully Disassembled with part count and itemized parts list (completely disassembled and includes only the parts to be coated). OR 2. Fully Assembled (springs, polymer parts, sights etc. will not be coated)

I understand and agree that once a work-order is approved by myself or the designated Company P.O.C. via email, phone call, text message, or in person that it will be considered "Active" and depending on the scope of work requested a cancellation or change order may not be possible. I certify that my company will make its best effort to not approve any work-order that is not ready for immediate processing.

I understand and agree Wright Armory, LLC will make every reasonable effort possible to provide accurate pricing. Pricing that is quoted sight unseen may change once the item in question has been received and reviewed by a Wright Armory gunsmith.

I understand and agree that **ALL ORDERS** sent in for metal finishing are required to: include an itemized P.O. or work order, with accurate part counts, all serial numbers listed, **AND** each firearm or group of parts will be bagged and tagged separately with all parts marked and or labeled and listed. If orders are sent in without an itemized list one will be created and you will be billed for the actual time to do so at the shop rate of \$90/hr.

I understand and agree that the warranty for metal finishing (NP3, NP3+, ArmorLube, Black Oxide, Stainless Blackening, or Parkerizing) for a period of one (1) year is against application or coating defects which include: bubbling, flaking, and peeling. Any damage or wear outside these defects will not be covered under warranty. Scratches, dents or dings caused by the dealer or the customer during reassembly or regular use will not be covered under warranty.

If you have a shipping account and would like to have it used for return shipping you may provide account number otherwise all orders ship via FedEx or UPS and are billed at the actual cost of shipping. Further more I understand and agree that due to the fluctuation is fuel costs and delivery surcharges that return shipping will not be calculated until: the work has been completed, the items have been repackaged, and are ready to ship out.
